1 OVERVIEW

1.1 Project Overview

This document is intended to be used by suppliers who will be sending item data to the ETRC leveraging GDSN. The goal of the ETRC project is to provide a digital solution that allows consumers to access regulatory product information in multiple languages by searching for a product's name or scanning the product barcode using a mobile device. Suppliers will be able to publish their data to ETRC and have it rendered on the Duty Free Label Solution by using a GDSN certified data pool.

The benefits of sending data to ETRC via GDSN include but are not limited to the following:

- Increases completeness of item data ETRC specific validations ensures compliance with the ETRC requirements based on European regulatory guidelines for labeling
- Data Quality Ensures compliance with GDSN validations
- Existing GDSN items can be used and published towards the ETRC (Duty Free Label Solution)
- Up-to-date content sourced directly from Information Provider

By leveraging a GDSN certified data pool, suppliers are able to make their validated product content available to any consumer using the Duty Free Label Solution and automate the data loading and maintenance process.

- The GDSN Attributes and how to apply them in the ETRC use case
- Examples of how to provide compliant content
- In addition to the ETRC Data Model document, this document is a reference for the entire data delivery process

1.6 STEPS TO BEGIN PUBLISHING YOUR DATA TO ETRC

- 1. Understand the ETRC Attribute Requirements
 - a. ETRC's attribute requirements are outlined in the ETRC Data Structure document https://www.1WorldSync.com/lp/etrc/
 - b. In the data structure, you can find the attributes relevant to your product category
 - i. Column K Alcohol
 - ii. Column L Food
 - iii. Column M Fragrances & Cosmetics
 - c. Within the above columns, you can filter for the Mandatory and Optional attributes for your category
- 2. Load accurate and ETRC compliant product content into the GDSN certified data pool and ensure it is ready for publication
 - a. Contact your data pool for any education needed to complete this step
 - b. Note that you will not be able to publish the items to ETRC unless successfully validated against the validations applicable to your items.
 - c. In case you want to provide reference websites that the consumer can click on, please consider that the URL needs to start with https, http or www.
- 3. 1WorldSync will create a subscription on behalf of ETRC based on your Information Provider GLN
 - a. Reach out to servicedesk@1worldsync.atlassian.net to initiate this request.
- 4. Publish items to the ETRC GLN 5060777290009
 - a. Publish items applicable to travel retail product assortments
 - Publish at the highest level of the hierarchy Note that only the consumer unit will render on the Duty Free Label Solution
 - Unique GTINs are required as the item identifiers for the base unit and higher packaging levels respectively (Refer to http://www.gs1us.org/resources/standards for more information)
- Note that feedback will be provided on publications using Catalogue Item Confirmation (CIC) messages
 - a. The items are validated against the ETRC attribute requirements
- 6. Send ongoing item maintenance updates through your data pool to the ETRC GLN


